This Registration Document is valid for a period of twelve months from the date of approval.

This Registration Document includes details of the long-term and short-term credit ratings assigned to the Issuer by S&P Global Ratings UK Limited ("**S&P**"), Moody's Investors Service Limited ("**Moody's**") and Fitch Ratings Limited ("**Fitch**"). Each of S&P, Moody's and Fitch is established in the United Kingdom and registered under Regulation (EC) No 1060/2009 on credit rating agencies as it forms part of the domestic law of the United Kingdom by virtue of EUWA (the "**UK CRA Regulation**"). As such, each of S&P, Moody's and Fitch appears on the latest update of the list of registered credit rating agencies (as of the date of this Registration Document) on the UK FCA's Financial Services Register. The ratings each of S&P, Moody's and Fitch has given to the Issuer are endorsed by S&P Global Ratings Europe Limited, Moody's Deutschland GmbH and Fitch Ratings Ireland Limited, respectively, each of which is established in the European Economic Area and registered under Regulation (EC) No 1060/2009 on credit rating agencies.

### THE ISSUER AND ITS SUBSIDIARY UNDERTAKINGS

#### Introduction

HSBC is one of the largest banking and financial services organisations in the world, with a market capitalisation of (approximately) U.S.\$ 176.8 billion as at 31 December 2024.

The Issuer is a public limited company registered in England and Wales under registration number 617987. The liability of members is limited. It has its registered and head office at 8 Canada Square, London, E14 5HQ, United Kingdom; telephone number +44 20 7991 8888. The Issuer was incorporated on 1 January 1959 under the Companies Act 1948 as a limited company and was re-registered under the Companies Act 1985 as a public limited company. The Issuer is the ultimate holding company of the Group.

As at 31 December 2024, the Group had total assets of U.S.\$ 3,017,048 million, and total shareholders' equity of U.S.\$ 184,973 million. For the year ended 31 December 2024, the Group's operating profit was U.S.\$ 29,397 million on total operating income of U.S.\$ 65,854 million. As at 31 December 2024, the Group had a UK CRR common equity tier 1 ratio (on a transitional basis, meaning that the transitional provisions set out in Part Ten of the UK CRR (which as at 31 December 2024 meant the phase-in arrangements for the regulatory capital impact of IFRS 9) were applied in calculating the ratio) of 14.9 per cent. and a UK CRR common equity tier 1 ratio (on a non-transitional basis, meaning that the transitional provisions set out in Part Ten of the UK CRR were not applied in calculating the ratio) of 14.9 per cent.

Headquartered in London, HSBC operates through an international network in 58 countries and territories. Within these regions, a comprehensive range of banking and related financial services is offered to personal, commercial, corporate, institutional, investment and private banking clients.

In 2024, HSBC's products and services were delivered to clients through three global businesses: Wealth and Personal Banking, Commercial Banking and Global Banking and Markets.

HSBC's Wealth and Personal Banking served around 40 million customers globally, including 7.7 million of whom are international, from retail customers to ultra high net worth individuals and their families. To meet its customers' needs, it offered a full suite of products and services across transactional banking, lending and wealth.

HSBC's Commercial Banking business served around 1.2 million customers across 48 countries and territories, ranging from small enterprises to large companies operating globally. It partnered with businesses around the world, supporting every stage of their growth, international ambitions and sustainability transitions. HSBC's Commercial Banking business delivered value to its clients through its international network, financing strength, digital capabilities and its universal banking offering, including its global trade and payments solutions.

HSBC's Global Banking and Markets business supported multinational corporates, financial institutions and institutional clients, as well as public sector and government bodies. Global Banking and Markets is a leading provider of transaction banking, financing and risk management solutions to its clients. Its global network with expertise, particularly in Asia and the Middle East, provides a differentiated service to its clients' international financial requirements.

Effective from 1 January 2025, HSBC has implemented a new organisational business structure and will operate through four new businesses: Hong Kong; UK; Corporate and Institutional Banking and International Wealth and Premier Banking. The Group's supporting infrastructure is being realigned to support the four businesses. The new organisational business structure is discussed in more detail in the 2024 Annual Report and Accounts, which is incorporated by reference in this Registration Document.

#### Ratings

The Issuer has been assigned the following long-term credit ratings:

- A- by S&P. This means that S&P is of the opinion that the Issuer has a strong capacity to meet its financial commitments;
- A3 by Moody's. This means that Moody's is of the opinion that the Issuer is judged to be upper-medium-grade and subject to low credit risk; and
- A+ by Fitch. This means that Fitch is of the opinion that the Issuer poses expectations of low default risk, indicates strong capacity for payment of financial commitments and that this capacity may, nevertheless, be more vulnerable to adverse business or economic conditions than is the case for higher ratings.

The Issuer has also been assigned the following short-term credit ratings:

- A-2 by S&P. This means that S&P is of the opinion that the Issuer's capacity to meet its financial commitment on its short-term obligations is satisfactory;
- P-2 by Moody's. This means that Moody's is of the opinion that the Issuer has a strong ability to repay short-term debt obligations; and
- F1+ by Fitch. This means that Fitch is of the opinion that the Issuer has the strongest intrinsic capacity for timely payment of short-term financial commitments.

Each of S&P, Moody's and Fitch is established in the United Kingdom and is registered as a credit rating agency under the UK CRA Regulation.

A credit rating is not a recommendation to buy, sell or hold securities and may be revised or withdrawn by the rating agency at any time.

# **Major Shareholders**

The ordinary shares of the Issuer are widely held and the Issuer is not directly or indirectly owned or controlled by any one individual or group of collective shareholders. The Issuer is not aware of any arrangements which may result in a change of this position.

There are no existing or potential conflicts of interest that are material in relation to debt securities of the Issuer issued pursuant to a relevant prospectus or other offering document between any duties owed to the Issuer by the directors of the Issuer and the private interests and/or external duties owed by the directors of the Issuer.
