**The Board of Hang Seng Bank Limited has declared a third interim dividend in respect of the year ending 31 December 2017 of HK\$1.2 per share.**

The Board of Directors of Hang Seng Bank Limited (the “Bank”) today declared a **third interim dividend** in respect of the year ending 31 December 2017 of HK\$1.2 per share, which will be payable on Tuesday, 7 November 2017, to shareholders whose names appear on the Register of Shareholders of the Bank on Thursday, 19 October 2017.

The dividend as declared should not be taken as an indication of the level of profit or dividend for the full year of the Bank.

### REGISTER OF SHAREHOLDERS

The Register of Shareholders of the Bank will be closed for one day on Thursday, 19 October 2017, during which no transfer of shares can be registered.
