Remarks (if any):

The UK Companies Act 2006 has abolished the concept of authorised share capital with effect from 1 October 2009. To reflect this, the new Articles of Association adopted with effect from 1 October 2009 has been amended to remove any reference to authorised share capital.

As part of a technical internal capital reorganisation necessitated by the amended EU Capital Requirements Directive 2 (which applied from 31 December 2010), the Company cancelled its 301,500 non-voting deferred shares of £1 each which were held by a wholly owned subsidiary.

To facilitate the cancellation of the deferred shares and comply with the provisions of the Companies (Authorised Minimum) Regulations 2009, the Company issued one Series A Sterling Preference Share of £0.01 for £1.00.
